FINANCIAL LITERACY SEMINARS AND ONE-ON-ONE COUNSELING ARE OFFERED TO PROVIDE SUPPORT AND TOOLS TO MAKE IT THROUGH THE COSTLY PROCESS FINANCIALLY INTACT. SCHOLARSHIPS ARE OFFERED SO THAT SURVIVORS CAN REACH THEIR ACADEMIC GOALS. FUNERAL EXPENSES ARE COVERED IF FAMILIES NEED HELP. IN 2016, 360 PATIENTS AND THEIR FAMILIES WERE PROVIDED WITH FINANCIAL ASSISTANCE.
