As this new year progresses, we remain optimistic and full of hope for the months to come. The generosity of your support

continues to have a direct impact on the lives of our families. We are thrilled to share that as a direct result of your support, for the entirety of the first half of the year, we will be able to extend our COVID relief fund, providing emergency financial assistance for those who are still feeling the effects of the pandemic. Jay Fund Family Stories





Jalayah is a kind, brave and energetic nine-year-old girl who enjoys painting, unicorns, arts and crafts, swimming, and scary movies. She was diagnosed as a baby with congenital dysplastic kidney disease and underwent a kidney transplant in 2013. In April 2017, Jalayah was diagnosed with Post-Transplant Lymphoproliferative Disease (PTLD is classified as a lymphoma, a cancer that affect the lymphatic system.) She underwent chemotherapy which was completed in August 2017. Jalayah has had two relapses of PTLD, once in 2018 and again in June 2019. She underwent a stem cell transplant in April of 2020, and completed her chemo last month at Newark Beth Israel Medical Center in Newark, NJ.

Jalayah has older twin siblings, Jamiyah and Jeremiah. They live with their mom, Patrice. Their dad died a year before Jalayah's cancer diagnosis. As a single parent and her daughter's caregiver, Patrice has been unable to work since Jalayah's cancer diagnosis in 2017.

The Tom Coughlin Jay Fund has been there for this family through their long journey, providing financial assistance for household expenses, transportation and holiday support, as well as including them in various in-person and virtual events.

Most recently, the family's furnace cracked, and the repair company told them it would be 3-4 days to make the repair. The first night Patrice turned the oven on for warmth and stayed up all night to be sure the house didn't catch on fire. The stress of providing safe, warm shelter for her family along with Jalayah's post treatment follow-up scans was tremendous. Mom reached out to ask for assistance and the Jay Fund immediately agreed to pay for a hotel for three nights.

Four days later when the family returned home, Patrice reached out with this message, "Thanks a million again, we're home!!! We came back to a warm house this morning. I truly appreciate the Jay Fund from the bottom of my heart. I thank you a trillion times, we love you."





Theo

Chase says that her almost 9 year old son, Theo, has been asking to learn martial arts for a while. She has been hesitant to enroll him because his Glioma of Intracranial, a brain tumor, diagnosed in March of 2018, has affected his eyesight. When she saw that the Jay Fund was offering a virtual class, she jumped at the opportunity to sign Theo up. Chase said it was Theo's first time trying martial arts and he was tired towards the end but enjoyed every second. Chase has now enrolled Theo in martial arts after seeing he was able to do everything in the virtual class safely.

Patients and their siblings met virtually with Tim Nicklas, a professional animator and character designer. Tim talked about working in animation, the different shows he worked on (Spider-Man being one of those!), what goes into making a cartoon, and demonstrated the various steps to make a cartoon from a storyboard to animatics to final product. At the end, Tim surprised all the kids by asking them to send him their own drawings for him and his colleagues to animate!
